No emails or comments were sent to the town clerk pertaining to the O&M. A motion was made to adjourn by **Councilperson Sabo**, seconded by **Councilperson Hoffman**. All members agreed. - 6.) 6:55 p.m. **North Greenbush Preliminary Budget.** An explanation of a last year's rate and this year's rate was given, \$4.75 per thousand, last year to \$4.85 per thousand this year. One email was received at 6:53p.m. by the Town Clerk and was passed out to the Board members and will be included in the permanent minutes, which was answered by Anthony Germano.

Supervisor Bott wanted to thank Anthony Germano and the Department Heads for all their help with the Budget this year.

Councilperson Hoffman wanted to congratulate Supervisor Bott on his first Budget.

Councilperson Rogers appreciated all the hard work everyone put into the final budget. He was thankful that money was added to the North Greenbush Ambulance, as the Ambulance Committee met and they were concerned with the growth and calls that may be needed with all the continuous building in the town this additional revenue will help.
